

C-INDEX/II SOFTWARE LICENSE AGREEMENT

IMPORTANT - READ CAREFULLY

By opening the sealed packet(s) OR exercising your rights to make and use copies of C-INDEX/II, you agree to be legally bound by the terms of this Software License Agreement. If you do not agree to the terms of this Agreement, promptly return this package for a full refund.

C-INDEX/II SOFTWARE LICENSE

1. GRANT OF LICENSE. C-INDEX/II (C-INDEX) is licensed, not sold, by Trio Systems LLC ("Trio Systems") pursuant to the terms and conditions of this Agreement. Under this license:

a. One person, as an individual, may use C-INDEX for the purpose of designing, developing and testing your computer software.

b. You may make and use copies of C-INDEX for the purposes described in this Paragraph 1 and may install copies of C-INDEX on an unlimited number of computers, provided that you are the only individual using C-INDEX. If you are a corporation or an entity (such as a partnership or limited liability company), you may designate one individual to use C-INDEX in the manner described in this Paragraph 1. Once the individual user of C-INDEX is designated by you, however, the individual may not transfer C-INDEX to another individual unless the first individual leaves your company or is reassigned.

2. **RESTRICTED RIGHTS:** Unless and until you sign and deliver to Trio Systems the separate C-INDEX/II OBJECT CODE DISTRIBUTION LICENSE AGREEMENT (the Distribution Agreement), you have no right to re-distribute C-INDEX and your rights to incorporate C-INDEX into your software are restricted. The following restrictions apply to the use of C-INDEX under this Software License Agreement:

a. You may not incorporate C-INDEX, in whole or in part, into any other software, including your software, except for development, evaluation and testing purposes.

b. You may not re-distribute C-INDEX, in whole or in part.

c. You may not distribute any of your software in which C-INDEX or any object code or source code from C-INDEX is incorporated.

If you sign and deliver the Distribution Agreement supplied with the product, your license to use and re-distribute C-INDEX will be controlled by the Distribution Agreement instead of this License Agreement.

3. **OTHER RESTRICTIONS.** You may not rent, lease or transfer C-INDEX, except as expressly permitted in Paragraph 1 above.

4. **COPYRIGHT.** C-INDEX is owned by Trio Systems and is protected by United States copyright laws and international treaty provisions. Therefore, you must treat C-INDEX like any other copyrighted material (e.g. a book on a compact disk or tape). Any copying or re-distribution of C-INDEX or any portion of our software, except as expressly permitted in this License Agreement, is a violation of our legal rights.

5. **LIMITED WARRANTY**

Trio Systems warrants to you that for a period of ninety (90) days from the date of your purchase of C-INDEX, it will perform substantially in accordance with the enclosed documentation. If C-INDEX fails to so perform, Trio Systems will, at its option, either replace C-INDEX with a functionally equivalent program or refund the license fee you paid.

EXCEPT AS SPECIFIED IN THIS PARAGRAPH, THERE ARE NO WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND THE PROGRAM, DOCUMENTATION AND OTHER FILES ON THE MAGNETIC MEDIA ARE PROVIDED "AS IS." THESE ARE YOUR SOLE AND EXCLUSIVE REMEDIES for any and all claims that you may have against Trio Systems arising out of or in connection with C-INDEX, whether made or suffered by you or another person and whether based in contract or tort. IN NO EVENT WILL TRIO SYSTEMS BE LIABLE TO YOU OR ANY OTHER PARTY FOR DIRECT, INDIRECT, GENERAL, SPECIAL, INCIDENTAL, CONSEQUENTIAL, EXEMPLARY OR OTHER DAMAGES ARISING FROM THE USE OF OR INABILITY TO USE C-INDEX OR FROM ANY BREACH OF THIS WARRANTY, EVEN IF TRIO SYSTEMS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. (Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion or limitation may not apply to you.)
